The Fairgrounds will accept storage items on Saturday Nov 2, 2024 from 8:00 am - Noon.

Items will be removed on Saturday April 12, 2025 beginning at 8:00 am.

There will be **NO** access to the buildings for the period of time items are in storage.

Payment is due in full, payable to the Allamakee County Ag Society, when your item goes in, NO EXCEPTIONS.

**You are responsible for insurance coverage on your item/vehicle.**

Equipment must be winterized. LP gas tanks and batteries must be removed.

No Electrical use is available in any of the Fairground buildings.

Rodent control is not provided by the Fairboard.

The Fairboard is not responsible for damage or vandalism of stored equipment or items.

Vehicles stored in buildings with concrete floor must park on cardboard, not provided.

**Storage fees are as follows, for the time period covered in this contract.**

Vehicles/Campers/Boats/Trailers up to 20' in length - \$200

Each additional foot of length - \$10/foot
