FAIR HOURS:

Our gates are open from 6AM until 12AM every day. The pavilion will be open to the public from 11am-8pm Thursday through Friday and 9am-3pm on Saturday. Outside of exhibitor hours, the pavilion will be locked and closed to the public.

CET IID

Outdoor exhibitors are welcome to begin setting up their exhibits beginning **Tuesday**, **July 16th at 8AM**. Set up will continue on Wednesday, July 17 until 1PM. Pavilion exhibitors may begin set up **Thursday**, **July 18th at 8AM**. If other accommodations need to be made for set up, please let us know.

SECURITY:

Pavilion exhibitors are encouraged to have a representative attending their booth during operating hours. On grounds, security personnel will be present during off hours, as well as multiple security cameras mounted throughout the grounds.

LIABILITY INSURANCE:

A copy of your liability insurance must be sent in with your registration by June 15th. Failure to provide insurance will result in a forfeiture of your space. The Allamakee County Fair Board wishes to provide a safe and fun environment.
